

DESCRIPTION OF LANDS WITHIN

GLADES AND HENDRY COUNTIES, FLORIDA

Township 42 South, Range 29 East

All of Sections 25, 35 and 36 lying South of the Caloosahatchee River Canal.

Township 43 South, Range 29 East

All of Section 1.

All of Sections 2 and 3 lying South of the Caloosahatchee River Canal.

All of Sections 10 through 15.

Township 42 South, Range 30 East

All of Sections 25 through 30 lying South of the Caloosahatchee River Canal.

All of Sections 31 through 36.

Township 43 South, Range 30 East

All of Sections 1 through 18.

All of Sections 21, 28 and 29 lying Easterly of the Seaboard Coastline Railroad.

All of Sections 22 through 27.

All of Sections 35 and 36.

Township 42 South, Range 31 East

All of Section 30 lying South of the Caloosahatchee River Canal.

All of Section 31.

Township 43 South, Range 31 East

All of Sections 6, 7, 18 through 20, and 29 through 32.

Containing 32,542 Acres more or less.

Township 42 South, Range 30 East

Section 32: The South half (S 1/2); the Southeast one quarter of the Northwest one quarter (SE 1/4 of NW 1/4); South three quarters of the South one half of the Northeast one quarter (S 3/4 of S 1/2 of NE 1/4).

Containing 428 Acres more or less.

Section 33: South one half of the North one half of the Northwest one quarter of the Southeast one quarter (S 1/2 of N 1/2 of NW 1/4 of SE 1/4); the North one half of the Southeast one quarter of the Southwest one quarter (N 1/2 of SE 1/4 of SW 1/4).

Section 10: That portion described as follows: Commencing at the Northwest corner of the Southwest one quarter of said Section 10, run South 708 feet to a POINT OF BEGINNING: thence East parallel with the North line of said Southwest one quarter, a distance of 300 feet; thence South 108 feet; thence West 300 feet; thence North 108 feet to the said POINT OF BEGINNING.
